As a result of this amendment, importers may be eligible for a refund of the duties paid on importations made since June 1, 2014. Refund claims are to be made in accordance with the provisions of section 74 of the *Customs Act*, using a Form [B2, Canada Customs — Adjustment Request](#).

For certainty regarding the tariff classification of a product, importers may request an advance ruling on tariff classification. Details on how to make such a request can be found in CBSA [Memorandum D11-11-3, Advance Rulings for Tariff Classification](#), which is found on the CBSA Web site.
